What is the overall deductible?	<b>\$850</b> Individual / <b>\$2,550</b> Family for Tier 1 - preferred and <b>\$1,500</b> Individual / <b>\$4,500</b> Family for Tier 2 - standard network services. There is no coverage for non-network services. Tier 1 preferred deductible applies to Tier 2-standard deductible. Network deductible will not exceed Tier 2 limit.	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.
Are there services covered before you meet your deductible?	<b>Yes.</b> Preventive care, preventive prescriptions and copay services from network providers are covered before you meet your deductible.	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. Are there other deductibles for specific services?	<b>No.</b>	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan?	<b>\$7,900</b> Individual/ <b>\$15,800</b> Family for Tier 1 - preferred and <b>\$8,550</b> Individual/ <b>\$17,100</b> Family for Tier 2 - standard network services. There is no coverage for non-network services. Tier 1 preferred out-of-pocket applies to Tier 2-standard out-of-pocket. Network out-of-pocket will not exceed Tier 2 limit.	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan, they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
What is not included in the out-of-pocket limit?	<u>Premiums</u> , <u>balance billing</u> charges and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit.

Do you need a referral to see a specialist?	<b>No.</b>	You can see the specialist you choose without a referral.
